

Waiver of Liability

RELEASE executed on this, the _____ day of _____, 2026, by the Arizona Pointing Dog Club and the US Forest Service, Bureau of Land Management, Arizona Game & Fish Department, Arizona State Trust Lands and all other entities (Landowner(s)), herein referred to as Releasees. All parties acknowledge this Release covers the entire annual season of events.

In consideration of being permitted to participate in organized bird dog trial activities of the shoot to retrieve variety, conducted by Releasors, for themselves, their spouses, heirs, minor children and assigns, Releasors hereby release, waive and discharge Releasees, their officers and members, and each of them individually, their officers and employees, referred to as Releasees, from all liability to the Releasors, their spouses, if any, their legal representatives, heirs and assigns, for any and all loss or damage, and any claim for damages resulting therefrom, on account of injury to Releasor's person or property, even injury resulting in death of Releasors, where caused by the negligence of Releasees or otherwise while the Releasors are competing, observing, or for any purpose participating in the aforesaid field trial or related Club event.

Releasors agree to indemnify the Releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of Releasors in or upon the field trial grounds whether caused by the negligence of the Releasees or otherwise by any other participating member or guest of a member of the Club.

Releasors hereby acknowledge that they know, appreciate, and understand the danger of competing or being in the vicinity of where live ammunition is used. The officials, and in particular the horse riders, know that horses are animals and as such, are susceptible to become excited or to otherwise attempt to dislodge their riders. Releasors further acknowledge there is no liability insurance on this event and in the event of injury because of the negligence of anyone, they must look to themselves for compensation and not to Releasees.

The Club may use an Electric Bike ("eBike") to assist in setting up the grounds, field maintenance and planting birds during an event. Releasors acknowledge riding or being in the vicinity of an eBike presents a risk of harm. Anyone who volunteers to ride the eBike in furtherance of club activity expressly assumes the risk of injury or death. The terrain is rough and rocky and presents potentially dangerous riding conditions. Riders are responsible for wearing protective gear while operating the eBike.
